- 2) 每個商務旅遊展報名費用為澳門幣\$2,000 圓正,所繳之報名費用將不獲發還,政府部門參展可獲豁免。經本局確認參展資格後 10 個工作天內繳交報名費用,否則被取消參展資格。
The participation fee for each trade show is MOP\$2,000 and not refundable. Government departments of the Macao S.A.R. are eligible for fee exemption. The participation fee shall be paid within 10 days as from the date of confirmation of respective eligibility by IPIM, otherwise their participation right will be cancelled.
