1. Pursuant to the regulation of Article 1479 of Civil Code, the conditions listed below constitute absolute prohibitions on marriage: a) aged under 16; b) apparent derangement despite during the period with sober senses, interdiction or interdiction of minor due to psychiatric disorders; c) existence of unterminated former marriage, even though such marriage record is not filed in relevant marriage registers.
2. According Article 1480 of Civil Code, marriage among lineal relatives or secondary class collateral relatives is strictly prohibited.
3. According to Article 18 of Law No.6/2004 – Law on Illegal Immigration, Illegal Stay and Deportation, anyone attempting to obtain the legal document required for entering Macao, staying in Macao or residency in Macao, with means described in items a) and b) of Paragraph 1 under Article 244 of the Penal Code, or by falsifying public documents, certified documents or private documents, may constitute a “Falsification of Document”;
4. This declaration must be signed within three months from the day the relevant application is filed.
