Part 7 - Declaration of Applicant/Interested Party consent and power of attorney

- 1) I hereby undertake to abide by Administrative Regulation no.3/2005 and other regulations from the date of application submission to the expiry date of my Macao SAR Temporary Residency.
- (2) I confirm that I have read and fully understood the "Macao SAR Temporary Residency Application Guidelines" which lays out all essential information needed for applying Macao SAR Temporary Residency before submitting this application for temporary resident to the Macao Trade and Investment Promotion Institute (hereinafter referred to as "IPIM"). I confirm that all information given in this application is true and I know that I will be responsible for relevant legal consequences if any information or documentation furnished for this application either wittingly or unwittingly is found to be untrue or false, and that I understand that falsification of documents and making false statement are criminal offenses.
- 3) I have completed the declaration of criminal record and I am aware of the legal consequences I will be facing if the declaration is found to be untrue.
- 4) I hereby agree to autorise IPIM on requesting any information from other government departments, authorities or organisations for the purpose of processing and handling my temporary residency application.
- 5) I understand that even though all application documents are ready, the authority has absolute power to make a decision on whether or not to approve my application.
- 6) I understand that even if the result shown IPIM's Online Assessment System for Temporary Residency Application is "basic eligibility criteria matched", the final decision depends on the documents and actual conditions at the time when the application is submitted. IPIM has the right to the final interpretation of the assessment results and the absolute power to make decision on the approval.
- 7) I understand that the duration of processing my application will be prolonged if there is/are any additional accompanying family dependent(s).

 8) I am aware of the regulations set out in Article 11 of Administrative Regulation No.3/2005, which stipulates that in the event that there are reasonable evidence suggesting the interested party has make of false statement, falsification of document or is involved in any other irregular circumstances, no official result will be made regarding relevant application procedure, until relevant irregular circumstances are proved not existing or are rectified, without prejudice to other legal consequences
- 9) I am aware of the regulations in Article 12 of Administrative Regulation No.3/2005, which stipulates that the authorised department can announce the termination of the procedure in the event the procedure is suspended for more than six months due to reason(s) attributed to the interested party(-ies).
- 10) I understand that I am obligated to maintain the same legal status of temporary residency during application procedure and after gaining the approval of the application, or otherwise the temporary residency might be cancelled or invalidated. If there are any changes or terminations of legal status, I must notify IPIM in written form within 30 days since the change or termination of legal status takes place, or otherwise the temporary residency might be cancelled or invalidated. Changes or terminations of legal status include: Elimination/change of identity status, e.g. divorce, change of de facto marriage or adoption of children. While the status changes of application include 1) renewal of employment contract for managerial personnel or professional technician with special qualification, change of position/employing company; 2) status change of major investment or category of major investment; 3) status change of proprietorship of real estate, increase of mortgage, change to fixed deposit amounting MOP 500,000 or changes of investment status of enterprise in which the applicant has invested no less than 51% of
- (11) I understand that, according to Article 19 and Article 20 of Administrative Regulation no. 3/2005, after the approval of temporary residency, applicant has to apply for renewal within the first 60 days of the 90 days before the expiration of the temporary residency, and that failing to complete the renewal application within the specified period will result in the invalidation of temporary residency.
- 12) I am aware of Item (3) of Paragraph 2 under Article 43 of Law No 16/2021, which regulates that when a residency holder stops living in the Macao SAR as an ordinary resident, or no longer meets the requirements or prerequisites for having the residency, the Chief Executive shall issue dispatch to terminate/revoke the relevant residency permit.
- (13) I understand that all documents submitted for this temporary residency application will not be returned.
- (14) I undertake to submit the copy(-ies) of my Macao Permanent Identity Cards and those of my accompanying family dependent(s) to IPIM once I/we have been issued the Macao Permanent Identity Card(s), I/we will submit a copy of each applicant to IPIM as soon as possible for record. Failing to fulfill this requirement will be disadvantageous to all and any applications I make to IPIM thereafter.
- (15) I hereby promise to maintain the crucial legal status during my residency application before my family dependent(s) has/have been granted temporary residency for less than 7 years even after I obtain a permant Macao ID, or otherwise the temporary residency of my dependents might be cancelled or invalidated.
